AMENDMENT ORDINANCE NO VI

ORDINANCE NUMBER VI

RELATING TO THE AMMENDMENT OF ORDINANCE NO. 6 OF THE VILLAGE OF GEORGETOWN, IDAHO, BE IT ORDAINED BY THE CHAIRMAN AND VILLAGE BOARD THAT ORDINANCE NO. 6 BE AMMENDED TO READ AS FOLLOWS TO WIT:

AN ORDINANCE TO REGULATE

THE RUNNING AT LARGE OF STOCK

SEC 1 THAT IT SHALL BE UNLAWFUL FOR ANY CATTLE, HORSES, MULES, SHEEP, GOATS, HOGS OR FOWLS TO BE RUNNING AT LARGE AT ANY TIME DURING THE DAY OR NIGHT WITHOUT A DRIVER, HERDER OR ATTENDENT OR WITHOUT PROPER MEANS OF CONTROLLING SUCH LIVE STOCK OR FOWLS SO AS TO TRESPASS.

WITHIN THE LIMITS OF SAID VILLAGE

SEC 1 THAT IT SHALL BE UNLAWFUL FOR ANY CATTLE, HORSES, MULES, SHEEP, GOATS, HOGS, OR LIVE STOCK OF ANY KIND, TO BE RUNNING AT LARGE, WITHOUT A DRIVER, HERDER OR ATTENDANT AT ANY TIME DURING THE DAY OR NIGHT WITHIN THE CORPORATE LIMITS OF SAID VILLAGE OF GEORGETOWN IN THE COUNTY OF BEAR LAKE AND STATE OF IDAHO, AND SUCH LOOSE STOCK FORTHWITH BE IMPOUNDED BY THE VILLAGE POLICE AND RELEASED ONLY UPON PAYMENT BY THE OWNER THEREOF OF ALL DAMAGES DONE BY SUCH ANIMALS TOGETHER WITH THE COSTS OF IMPOUNDING WHICH SHALL BE 50 CENTS EACH, AND KEEPING OF SUCH ANIMALS WHICH SHALL BE 25 CENTS A DAY PER HEAD FOR CATTLE, 10 CENTS A DAY FOR SHEEP, GOATS AND HOGS AND 25 CENTS A DAY FOR EACH HORSE OR MULE; IF NOT SO REDEEMED WITHIN THREE DAYS AFTER CONFINEMENT SHALL BE SOLD AT PUBLIC AUCTION AFTER ADVERTISEMENT BY POSTING NOTICES OF SALE IN THREE PUBLIC PLACES WITHIN THE VILLAGE FOR 10 DAYS AND ALL PROCEEDS FROM SUCH SALE OR SALES, AFTER PAYING THE SAID DAMAGES AND ACCRUED COSTS, SHALL BE REFUNDED TO THE OWNER OF SUCH ANIMALS ON DEMAND.

LIVE STOCK OR FOWLS FOUND IN VIOLATION OF THIS AMMENDED ORDINANCE SHALL BE IMPOUNDED BY THE VILLAGE MARSHALL AND RELEASED ONLY UPON PAYMENT BY THE OWNER. ALL DAMAGES DONE BY SUCH LIVE STOCK OR FOWLS TOGETHER WITH COSTS OF 50 CENTS (\$0.50) PER HEAD FOR LIVE STOCK AND FIFTEEN CENTS (\$0.15) FOR FOWLS. FOR MAINTENANCE AS FOLLOWS AN ALLOWANCE SHALL BE MADE. TWENTY FIVE CENTS (\$0.25) PER HEAD PER DAY FOR ALL CATTLE, HORSES, MULES; TEN CENTS (\$0.10) PER DAY FOR EACH HEAD OF GOATS SHEEP OR HOGS AND FIVE CENTS (\$0.05) PER HEAD PER DAY FOR FOWLS.
