SEC 4 THAT IT IS DECLARED A MISDEMEANOR TO PLAY FOOTBALL, BASEBALL OR ANY SUCH GAMES, UPON ANY OF THE HIGHWAYS. ANYONE VIOLATING THIS ORDINANCE SHALL BE FINED NOT EXCEEDING \$100.

SEC 6 THAT IT IS DECLARED A MISDEMEANOR FOR ANYONE TO FIRE A GUN OR PISTOL WITHIN THE INCORPORATION LIMITS UNDER PENALTY NOT EXCEEDING \$100. THIS SHALL NOT IN ANY MANNER AFFECT THE SHOOTING OF AN ANIMAL ON A PERSON'S OWN PREMISES IF DONE WITH REASONABLE CARE.

SEC 9 THAT ANY MINOR FOUND LOAFING OR LOITERING UPON THE STREET OR HIGHWAYS OF GEORGETOWN, OR IN OR ABOUT SALOONS, GAMING OR BAWDY HOUSES, BETWEEN THE HOURS OF 9 O'CLOCK P.M. AND 6 O'CLOCK A.M. UNACCOMPANIED BY A PARENT, GUARDIAN OR OTHER SUITABLE ADULT PERSON AND UNABLE TO GIVE A REASONABLE EXPLANATION OF HIS OR HER PRESENCE THERE, SHALL BE GUILTY OF A MISDEMEANOR PUNISHABLE BY A FINE NOT EXCEEDING \$100.

SEC 15 THAT ANY PERSON WHO CRUELLY SHIPS, BEATS, OR OTHERWISE UNNECESSARILY ILL-TREATS AN ANIMAL, OR WORRIES WITH DOG ANY CATTLE, HORSES, SHEEP OR HOGS, WITHIN THE VILLAGE LIMITS OF GEORGETOWN, IS GUILTY OF A MISDEMEANOR AND PUNISHABLE BY A FINE NOT EXCEEDING \$100 OR BY IMPRISONMENT NOT EXCEEDING SIX MONTHS.

Sec. 1

That it is declared a Misdemeanor for any one to be drunk or disorderly in such a manner as to disturb the quiet of the neighborhood, on the peace and dignity of the Village. Any one guilt of the above act or acts shall be subject to a fine not exceeding \$50.

Sec. 4.

That it is declared a misdemeanor to play football, baseball or any such games any if the highways. Any one avoiding this ordinance shall be fined, not exceeding \$100.
